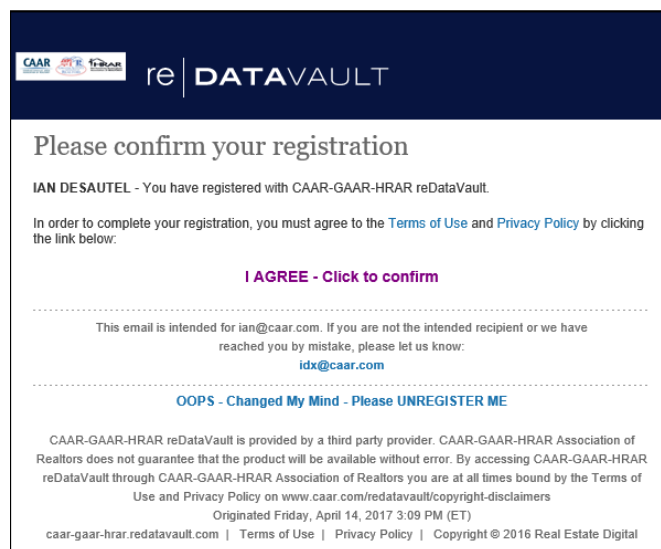
Broker Instructions -NEW to reDataVault

In the window that opens, enter your SSO/Paragon username and click **Find**. The window will show your name and your brokerage name.

Select the **Apply** button that will auto fill your name and your Organization info.

Please enter your email address, choose a password, scroll to the bottom, and select **Next Step**.

The system is going to send you an enrollment confirmation email. That will look like this:



Click the "I AGREE – Click to confirm" your account.

You are now able to choose one or more data products to license.

STEP 2: Apply for a Data License

Upon Sign-In, select **Apply Now** for the appropriate product and follow the prompts to complete the license.

Digital Signatures in CHROME Browsers:

As a CHROME user, you need to follow these steps to initialize your CHROME browser. You only need to do this ONCE.

 - b. **Domain Name(s) of Brokerage Firm Utilizing this Licensee** - Use this area for top level domains example. Amazon.com, google.com, Microsoft.com
 - c. **OPTIONAL: Display Websites and Other Solutions for Agent Subscribers Via reDataVault** – IF you expect that multiple agents in your firm may want to work with this vendor please check this box. Then All we have to do is amend this agreement with additional URLs rather than creating a whole new agreement for each agent.
